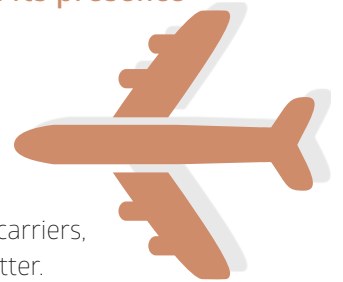

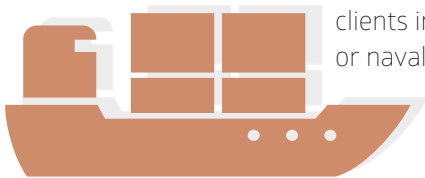


● TRANSPORTATION AND INSURANCE LAW
